

ORDINANCE NO. 467

AN ORDINANCE OF THE BOROUGH OF MANSFIELD, TIOGA COUNTY, PENNSYLVANIA, TO AMEND THE CODE OF THE BOROUGH OF MANSFIELD, CHAPTER 155 "VEHICLES AND TRAFFIC", ARTICLE II, "TRAFFIC REGULATIONS", BY AMENDING SECTION 155-11, "PROHIBITED TURNS AT INTERSECTIONS", BY ADDING A PROHIBITION ON LEFT TURNS ON HOARD STREET NORTH BOUND AT EAST WELLSBORO FROM 7 A.M. TO 7 P.M. AND BY ADDING A PROHIBITION ON LEFT TURNS ON SASAFRAS STREET SOUTH BOUND AT WEST WELLSBORO FROM 7 A.M. TO 7 P.M. AND BY ADDING A PROHIBITION ON LEFT TURNS ON CENTER STREET EAST BOUND AT NORTH MAIN STREET FROM 7 A.M. TO 7 P.M., BY AMENDING SECTION 155-14 "STOP INTERSECTIONS", BY ADDING A STOP SIGN ON SOUTH ACADEMY STREET SOUTH BOUND TO STOP AT THIRD STREET AND BY ADDING A STOP SIGN ON ST. JAMES STREET SOUTHBOUND TO STOP AT THIRD STREET, BY AMENDING SECTION 155-16 "YIELD RIGHT OF WAY INTERSECTIONS", BY REMOVING ST. JAMES STREET SOUTH BOUND YIELD AT THIRD STREET, AND TO AMEND THE CODE OF THE BOROUGH OF MANSFIELD, CHAPTER 155 "VEHICLES AND TRAFFIC", ARTICLE III SECTION 155-28 "PARKING PROHIBITED AT ALL TIMES", BY ADDING MORRIS STREET, NO PARKING ON BOTH SIDES OF THE ENTIRE LENGTH OF THE STREET, BY ADDING MEADOW STREET, NO PARKING ON THE WEST SIDE OF THE ENTIRE LENGTH OF THE STREET, BY ADDING SOUTH ACADEMY STREET, NO PARKING ON THE EAST SIDE OF THE STREET FROM SECOND STREET TO THIRD STREET, BY ADDING NORTH HILL TERRACE, NO PARKING ON THE NORTH SIDE OF THE STREET, BY ADDING MANN STREET, NO PARKING ON THE SOUTH SIDE OF THE STREET, BY ADDING CLARK STREET, NO PARKING ON BOTH SIDES OF THE STREET, BY ADDING EAST ELMIRA, NO PARKING ON THE NORTH SIDE OF THE STREET FROM NORTH ACADEMY TO EXTENSION STREET, BY ADDING NORTH ACADEMY STREET, PARKING FOR CHURCH SERVICES ONLY FROM SHERWOOD TO EAST WELLSBORO, BY REMOVING SOUTH ACADEMY, NO PARKING ON EAST SIDE FROM MORRIS DRIVE TO FIRST STREET, BY REMOVING CLINTON STREET, NO PARKING ON EAST SIDE FROM FIRST STREET TO SECOND STREET AND ADDING CLINTON STREET, NO PARKING ON THE EAST SIDE FROM A POINT 80 FEET SOUTH OF FIRST STREET TO SECOND STREET, BY AMENDING SECTION 155-30 "TIME LIMIT PARKING", BY REMOVING 2 HOUR PARKING ON THE NORTH SIDE OF EAST ELMIRA STREET FROM NORTH ACADEMY TO A POINT 312 FEET EASTERLY THEREOF, BY REMOVING 2 HOUR PARKING ON THE SOUTH SIDE OF EAST ELMIRA STREET FROM A POINT 80 FEET

EAST OF NORTH ACADEMY TO EXTENSION STREET, BY ADDING CLINTON STREET'S EAST SIDE FROM A POINT 40 FEET SOUTH OF FIRST STREET TO A POINT 80 FEET SOUTH OF FIRST STREET FROM 6:00 A.M. TO 3:00 A.M. FOR ONLY 15 MINUTES AT A TIME.

BE IT ORDAINED AND ENACTED by the Borough Council of the Borough of Mansfield, Tioga County, Pennsylvania as follows:

SECTION 1. Chapter 155, Vehicles and Traffic, Article II, Traffic Regulations, Section 155-11, Prohibited turns at intersections, is hereby amended to **add** the following:

Name of Highway	Direction of travel	Prohibited turn	At intersection of
Hoard Street	North	Left 7AM to 7PM	East Wellsboro
Sasafras Street	South	Left 7AM to 7PM	West Wellsboro
Center Street	East	Left 7AM to 7PM	North Main

SECTION 2. Chapter 155, Vehicles and Traffic, Article II, Traffic Regulations, Section 155-14, Stop Intersections, is hereby amended to **add** the following:

Name of Highway	Direction of travel	At intersection of
South Academy Street	South	Third Street
St. James Street	South	Third Street

SECTION 3. Chapter 155, Vehicles and Traffic, Article II, Traffic Regulations, Section 155-16, Yield right of way intersections, is hereby amended to **remove** the following:

Name of Highway	Direction of travel	At intersection of
St. James Street	South	Third Street

SECTION 4. Chapter 155, Vehicles and Traffic, Article III, Parking Regulations, Section 155-28, Parking Prohibited at all times, is hereby amended to **add** the following:

Name of Highway	Side	Location
Morris Street	Both	Entire length
Meadow Street	West	Entire length
South Academy Street	East	From Second Street to Third Street
North Hill Terrace	North	Entire length
Mann Street	South	Entire length
Clark Street	Both	Entire length
East Elmira	North	From North Academy to Extension Street
North Academy Street	West	From East Wellsboro to Sherwood Street except for Church Services
Clinton Street	East	From a point 80 feet south of First Street to Second Street

It is also amended to **remove** the following:

Name of Highway	Side	Location
South Academy	East	From Morris Drive to First Street
Clinton Street	East	From First Street to Second Street

SECTION 5. Chapter 155, Vehicles and Traffic, Article III, Parking Regulations, Section 155-30, Time Limit Parking, is hereby amended to **remove** the following:

Name of Highway	Side	Hours	Time Limit	Location
East Elmira Street	North	6:00a.m. to 3:00a.m.	2 hrs.	From North Street to North Academy Street to a point 312 feet easterly thereof
East Elmira Street	South	6:00a.m. to 3:00a.m.	15 mins.	From a point to 80 feet east of North Academy Street to Extension Street

It is also amended to **add** the following:

Name of Highway	Side	Hours	Time Limit	Location
Clinton Street	East	6:00a.m. to 3:00a.m.	15 mins.	From a point 40 feet south of First Street to a point 80 feet South of First Street.

SECTION 6. Severability

The provisions of this Ordinance are severable. If any sentence, clause, or section of this Ordinance is for any reason found to be unconstitutional, illegal, or invalid it shall not affect or impair any of the remaining provisions, sentences, clauses, or sections of this Ordinance. It is hereby declared to be the intent of the Borough that this Ordinance would have been adopted had such unconstitutional, illegal, or invalid sentence, clause, or section had not been included herein. Any Ordinance or any part of any Ordinances, conflicting, with the provisions of this Ordinance, be and the same is hereby repealed, so far as the same affects this Ordinance.


SECTION 7. Effective date.




