ORDINANCE NO: 481 OF 2017

AN ORDINANCE OF THE BOROUGH OF MANSFIELD, TIOGA COUNTY, PENNSYLVANIA, OPENING AND ORDAINING UNIVERSITY VIEW, DORSETT HEIGHTS, & NADALINI DRIVE AS PUBLIC ROADWAYS AND/OR STREETS.

WHEREAS, the streets lying in the lot of land situate in the Borough commonly referred to as the I-99 Commerce Park known as University View and/or University Drive, Dorsett Heights, and Nadalini Drive, have already been constructed and are open for public use;

WHEREAS, pursuant to Motion of Borough Council on October 12, 2016 the Borough accepted said streets, known as University View and/or University Drive, Dorsett Heights and Nadalini Drive, upon recordation of a Deed of Dedication for the same; and

WHEREAS, a Deed of Dedication from the Betterment Organization of Mansfield to the Borough of Mansfield dedicating the streets known as University View and/or University Drive, Dorsett Heights, and Nadalini Drive, was recorded at the Tioga County Recorder of Deeds on November 9, 2016 as Instrument Number 201610108 and filed to the Tioga County Road Docket at the Tioga County Prothonotary's Office on November 17, 2016 to docket number 3 RD 2016; and

WHEREAS, the Borough Council desires to enact an ordinance to open and ordain the streets known as University View and/or University Drive, Dorsett Heights, and Nadalini Drive, to be hereafter known as University View, Dorsett Heights, and Nadalini Drive;

NOW THEREFORE, be it enacted and ordained by the Borough of Mansfield, Tioga County, Pennsylvania by authority of the same as follows:

SECTION 1: Enacted, ordained, and accepted as Borough public roadways and/or streets, effective July 12, 2017, are those streets lying in the lot of land situate in the Borough commonly referred to as the I-99 Commerce Park to be hereafter called University View, Dorsett Heights, and Nadalini Drive, described in the Deed of Dedication recorded at the Tioga County Recorder of Deeds on November 9, 2016 as Instrument Number 201610108 and filed to the Tioga County Road Docket at the Tioga County Prothonotary's Office on November 17, 2016 to document number 3 RD 2016, and being more fully set forth and accurately shown and

depicted upon a plan entitled Revised Subdivision Plan I-99 Business Park for the Betterment Organization of Mansfield by Larson Design Group, Project Number 5931-003, recorded on December 9, 2008 in Tioga County as Instrument Number 200811748.

SECTION 2: If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this Ordinance which can be given effect without the invalid provisions or application, and to this end the provisions of this Ordinance are severable.

SECTION 3: If any sentence, clause, section or part of this Ordinance is found to be unconstitutional, illegal or invalid for any reason such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses or sections or parts of this Ordinance. hereby declared as the intent of the Borough that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof, not been included herein.
