ORDINANCE NO. <u>487</u> OF 2018

AN ORDINANCE OF MANSFIELD BOROUGH, TIOGA COUNTY, PENNSYLVANIA, AMENDING CHAPTER 155, VEHICLES AND TRAFFIC, ARTICLE III, PARKING REGULATIONS, OF THE BOROUGH'S ORDINANCES TO ALLOW FOR CERTAIN ADDITIONAL AND/OR ADDITIONAL HOURS OF PARKING AND ALSO TO RESTRICT CERTAIN PARKING IN THE BOROUGH

WHEREAS, the Borough Council of the Borough of Mansfield, Tioga County, Pennsylvania, deems it to be in the best interests and safety of the citizens and residents of the Borough of Mansfield to amend Chapter 155, Vehicles and Traffic, Article III, Parking Regulations, as follows;

NOW THEREFORE, BE IT ORDAINED AND ENACTED, by the Borough Council of the Borough of Mansfield, Tioga County, Pennsylvania as follows:

SECTION 1. Chapter 155, Vehicles and Traffic, Article III, Parking Regulations, section 155-28, Parking Prohibited at all times, is hereby amended to **add** a provision prohibiting all on street parking on any street (both sides) located in the 1-99 Business Park.

SECTION 2. Chapter 155, Vehicles and Traffic, Article III, Parking Regulations, section 155-28, Parking Prohibited at all times, is hereby amended to **add** a provision prohibiting parking on both sides of Clinton Street South of First Street.

SECTION 3. Chapter 155-30, Vehicles and Traffic, Article III, Parking Regulations, section 155, Time limit parking, is hereby amended to remove the 2-hour limitation for parking on the East side of South Main Street from College Avenue to Wellsboro Street and on the East side of South Main Street beginning at a point 62 feet North of the intersection of East Main Street and South Main Street and extending in a Northerly direction for 40 feet and 7 inches, thus allowing for all day parking (except during the hours of 3:00 a.m. through 6:00 a.m.) on the East Side of South Main Street from College Avenue to Wellsboro Street and on the East side of South Main Street beginning at a point 62 feet North of the intersection of East Main Street and South Main Street and extending in a Northerly direction for 40 feet and 7 inches.

SECTION 4. Chapter 155-30, Vehicles and Traffic, Article III, Parking Regulations, section 155, Time limit parking, is hereby amended to **remove** the 2-hour limitation for parking on both sides of North Main Street from Sherwood Street to East Elmira Street, thus allowing for all day parking (except during the hours of 3:00 a.m. through 6:00 a.m.) on both sides of North Main Street from Sherwood Street to East Elmira Street.

SECTION 5. Chapter 155, Vehicles and Traffic, Article III, Parking Regulations, section 155-31, Special purpose parking zones, A, Handicapped parking spaces, is hereby amended to **add** a provision authorizing an additional authorized handicapped person parking spot on South Academy Street located in front of 197 South Academy Street.

SECTION 6: If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this Ordinance which can be given effect without the invalid provisions or application, and to this end the provisions of this Ordinance are severable.

SECTION 7: If any sentence, clause, section or part of this Ordinance is found to be unconstitutional, illegal or invalid for any reason such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses or sections or parts of this Ordinance. It is hereby declared as the intent of the Borough that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof, not been included herein.

SECTION 8: This Ordinance shall become effective five (5) days after enactment.
