

ORDINANCE NO. 493

AN ORDINANCE OF MANSFIELD BOROUGH, TIOGA COUNTY, PENNSYLVANIA, AMENDING CHAPTER 155, VEHICLES AND TRAFFIC, ARTICLE III, PARKING REGULATIONS, OF THE BOROUGH'S ORDINANCES TO AMEND SECTION 155-31 (B) SPECIAL PURPOSE PARKING ZONES, LEASED SPACES IN BOROUGH PARKING LOT.

WHEREAS, the Borough Council of the Borough of Mansfield, Tioga County, Pennsylvania, deems it to be in the best interest and safety of the citizens and residents of the Borough of Mansfield to amend Chapter 155, Vehicles and Traffic, Article III, Parking Regulations, as follows;

NOW THEREFORE, BE IT ORDAINED AND ENACTED, by the Borough Council of the Borough of Mansfield, Tioga County, Pennsylvania as follows:

SECTION 1. Chapter 155, Vehicles and Traffic, Article III, Parking Regulations, section 155-31 Special purpose parking zones, B, Leased spaces in Borough parking lot, is hereby amended to read:

Lease spaces in Borough lot. No person, except the authorized permit holders, shall park any vehicle in the Municipal Parking lot located on West Wellsboro Street between Railroad Street and Sassafras Street. All vehicles authorized to park in said lot must have a parking permit issued by the Mansfield Police Department. Only the lessee of the parking space is authorized to purchase the parking permits or replacement permits. If in the event a permit is lost, misplaced, stolen or in need of replacement for any reason, the lessee will be charged a replacement fee cost of \$50.00.

SECTION 2: If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this Ordinance which can be given effect without the invalid provisions or application, and to this end the provisions of this Ordinance are severable.

SECTION 3: If any sentence, clause, section or part of this Ordinance is found to be unconstitutional, illegal or invalid for any reason such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses or sections or parts of this Ordinance. It is hereby declared as the intent of the Borough that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof, not been included herein.

SECTION 4: This Ordinance shall become effective January 1, 2020.
